## EXCELLENCE IN IMPACT: TNC HONORED FOR GROWTH & QUALITY

In a metro area with nearly 3,000 nonprofit agencies, TNC Community was selected to receive the 2022 Excellence in Impact award from Nonprofit Connect. This is Kansas City’s oldest and largest celebration of nonprofit excellence, and puts TNC alongside past recipients such as Big Brothers Big Sisters, United Way, and Children’s Mercy Hospital. This is a huge honor!



In addition, the Independence Economic Development Council named TNC Community the city’s Nonprofit Business of the Year. TNC is grateful for the partnerships that helped make these recognitions possible. We thank our families, collaborative agencies, community supporters, and our committed staff.

These awards recognize the difference TNC makes for individuals with developmental disabilities, and our ability to expand services during times that were the most challenging for service providers across the nation. Since 2020, TNC has grown to serve 60% more individuals with IDD. By summer 2022, we will have gone from offering around-the-clock support in 10 homes to 16, plus we added an Independent Living Assistance Program to facilitate community integration for individuals living on their own with IDD.



TNC Community stands out from other providers because we specialize in supporting medically-fragile people with IDD (71% of residents). Committed Personal Support Attendants and a dedicated Health Services Team of registered nurses and care coordinators work together to accommodate a high level of complex needs without limiting community engagement.

Without access to home environments like TNC provides, individuals with IDD often languish in facilities not designed for their needs. TNC offers around-the-clock care in group-living homes in suburban neighborhoods across Kansas City's Clay, Jackson, and Platte counties. It is our mission to provide customized support so people with IDD can experience interdependent living, education, and community involvement in alignment with their personal goals and interests.

Each person TNC Community serves through our Independent Living Assistance Program is unique. Community Connections Coordinators work with our ILAP friends to build their social networks, seek better employment opportunities, start their own businesses, and more as they work towards greater independence.

Randy has been making strides through involvement with community advocacy and becoming more efficient at meal preparation. For weeks, he talked about wanting a George Foreman grill but his income is very limited. Staff obtained a donated indoor grill and taught him how to cook on it, step-by-step, ensuring all safety measures were taken.

Randy uses his new grill every week and boasts about how great a chef it has made him! He now wants to learn more since mastering the grill so quickly.

Together we make a difference for individuals with intellectual and developmental disabilities! For Randy, the donation of a small kitchen appliance combined with assistance from the TNC Team changed his day-to-day life for the better, adding confidence, independence, and some really good meals!


